## Copyright Amendment (Disability Access and Other Measures) Act 2017 (Cth),

Goes beyond the requirements of the Marakesh treaty by providing solutions not only to those with a print disability, but to those with <u>any</u> disability.

# **Disability Discrimination Act**

The definition of 'disability' applied in the Copyright Act is the same as the definition of disability in s 4 of the Disability Discrimination Act 1992 (Cth). It includes:

- physical, intellectual, sensory, neurological, learning and psychosocial disabilities, diseases or illnesses
- physical disfigurement, medical conditions, mental illness and work-related injuries
- temporary or permanent disability
- disabilities that affect all or only part of a person's bodily or mental functions.

## Two exclusion sections:

I. section II3E 'Fair dealing for purpose of access by persons with a disability'
2. section II3F 'Use of copyright material by organisations assisting persons with a disability'

Both sections allow accessible versions of copyright material to be created and supplied to a person or persons with a disability, if they would otherwise have difficulty reading, viewing, hearing or comprehending the material.

## Scope of application:

Both exceptions apply equally to: all types of material – this includes books, movies, music, computer programs, forms or any other content that is covered by copyright

- provide it to the person who needs it.
- all persons with a disability.
