
## 2008


# **Redefining the Workshops**



## Recommendations

- Offer face to face workshops to all staff, collaborative approach
- Increase the number of workshops (quarterly), based on staff movements
- Face to face training content complements online training
- Workshops to provide broad range of practical examples and case scenarios
- Workshops to encourage sharing of information, and opportunity for discussion and networking
- Promote awareness of supports and services available to staff and students via workshops
